Ref: Board's Letter of even number dated 18.6.2014 & 12.8.2014.

Reference Board's letter of even number dated 18.6.2014 and 12.8.2014 wherein the forms of patients and disabled persons have been revised w.e.f. 15.7.2014. In the instructions it has been clearly mentioned that the concession certificates already issued on the pre-revised forms shall continue to be valid till the expiry period of the concession certificate's validity.

Number of complaints are being received that concession to escorts in case of patients are being refused at many stations stating that there is no mention in the forms about escorts.

Ministry of Railways desire that concession to disabled and patients and the escorts may be granted in accordance with the rules contained in IRCA Coaching Tariff Part-I (volume-II). No changes have been made as regards concession to escorts. The disabled persons/patients should be dealt with compassion & sympathy and must not be harassed on flimsy grounds. The complaints received by Zonal railways in this regard should be taken up seriously.

Necessary instructions may be issued to the staff concerned immediately, should be issued to all concerned.
